Opening keynote address	Employees everywhere are experiencing increased stress, anxiety, and isolation. A thriving workforce begins with purposeful people and connection to what matters most and starting at the heart of the matter—emotional well-being. Developing an authentic and shared sense of purpose is foundational to overall well-being in our lives and our organizations—especially now. New data on Americans during the pandemic show that purpose not only amplifies engagement, it improves our mental well-being as well. And employees realize a greater sense of meaning, dignity, and empowerment as a result.
	A stronger sense of purpose in our work builds resilience to stress, lowers employee burnout risk by helping people live meaningful lives, reduces depression risk, creates an inclusive culture that is open to change, and helps people fulfill a purpose. In this session, you will learn about the science and practice of building purposeful, thriving organizations. Dr. Strecher will explore current scientific research illustrating the positive impact an authentic and well-communicated purpose can have on individuals, teams, and organizations, as well as some keys to help you unlock your own potential.
	Victor J. Strecher , PhD, MPH, Professor, University of Michigan School of Public Health, Founder and Chief Purpose Officer, Kumanu. An award-winning pioneer in the field of behavioral science and professor at the University of Michigan School of Public Health, Dr. Strecher lost his 19-year-old daughter, Julia, to a rare heart disease that resulted from an infant case of chicken pox. This life event challenged every aspect of Strecher's personal and professional experience and drove him to an exhaustive search, from ancient philosophy to cutting-edge science, to pinpoint the potential and impact of purpose in our lives. What is it? How can we discover it? And what does the latest research tell us about the importance of how purpose affects our overall health and happiness?

Aligned with The Children's Center mission, To Help Children & Families Shape Their Own Futures, the Crisis to Connection Imperative is centered around improving outcomes for Black boys by addressing trauma and systemic racism in Detroit at the micro (individual), mezzo (intrapersonal and community), and macro (systems and policies) levels. Black boys are disproportionately affected by implicit bias, racism, and a lack of trauma-informed community support systems. They experience trauma at a much higher rate than their white counterparts. This presentation will explore the three-phase process that The Children's Center has begun and how they are intentionally calling to action members from various systems that directly impact the lives of Black boys.

(e)	Youth-serving organizations are being asked to treat increasingly complex and traumatized children within a shorter time frame. <i>Family First</i> legislation requires organizations to use a trauma-informed care (TIC) framework recognizing that, to treat and safely manage these youth, they must increase clinical sophistication and knowledge of trauma. Because our clients are hurt through relationships, we must use the science of relationships to improve our treatment. This session will discuss key program elements of a TIC organization that includes the science of safety and connection as applied to both healing each client's trauma history, as well as supporting staff with recognizing and regulating their own activating triggers. Effective use of calming rooms for clients and exercises to strengthen staff's ability to recognize and regulate strong reactions to client behavior will be discussed.
	Mary Jo Harwood , LSW, DNCCM, is a Program Coordinator for the Traumatic Stress Institute (TSI) of Klingberg Family Centers. Using the Risking Connection curriculum and a Whole-system Change Model, Harwood provides training and implementation coaching to organizations across North America on transforming their services and programs to trauma-informed care. A significant part of her 30+ years as a licensed social worker has been spent supporting the recovery of individuals and communities post-traumatic incidents. She has provided trauma-informed leadership to victim service organizations, congregate care settings, and mental health providers, and she has served in the capacity of a trauma therapist, EMDR practitioner, and crisis responder.
	Meredith Reese , LPC, Chief Integrated Behavioral Health Officer, has been with Vista Maria since July 2003. In her current role, she is responsible for the integration of mental health and physical health services on campus serving all youth in care. She holds a certification in Integrated Behavioral Health and Primary Care–Pediatric Track and holds 20 years of extensive knowledge in areas of mental health, trauma, and adolescent development. Reese holds a master's degree in mental health counseling with an emphasis in marriage and family therapy and is a Licensed Professional Counselor. In addition, she is a featured speaker, presenter, and trainer relating to human trafficking and trauma and a Board Member of the Michigan Human Trafficking Taskforce.

3:00 PM-4:30 PM Closing keynote	How Malnutrition in Vietnam Helped One Agency Become Restraint Free Four years ago, Methodist Children's Home Society embarked on a mission to become restraint free. Despite experiencing more youth with challenging behaviors and more families with complex needs, MCHS committed to incorporating a trauma-informed treatment program. As a result, MCHS saw an 86% decrease in restraints within a four-year period and experienced its first 180 days of being restraint free in 2020. Other maladaptive behaviors, such as property destruction, physical aggression, and AWOL decreased significantly. Come learn how one organization utilized Trauma-Informed Cognitive Behavioral Therapy (TF-CBT), aspects of Building Bridges and Therapeutic Crisis Intervention (TCI), along with a few other initiatives, and became restraint free and improved outcomes for its youth and families.
	Kevin Roach , LMSW, is CEO of Methodist Children's Home Society (MCHS), having served since 2015. He brings nearly 20 years of leadership in the child welfare and nonprofit world, having served in a variety of settings and with diverse populations and organizations across the country. At MCHS, he has led the agency through ambitious strategic plans, creating new programs in education, housing, and other community-based services, seeing agency revenues increase 217% during his tenure. Passionate about children and families, Roach is a reading enthusiast, wannabe foodie, recovering political junkie, and golf hack, but his best title is Dad.



Unhealthy adolescent behaviors often occur due to past experiences and often have roots in family systems or family dysfunction. 


2Gen Approach to Family Preservation and Engaging Families

Facing extraordinary challenges, family preservation teams are engaged with families throughout the state focusing on providing services to entire families in order to keep child-welfare-involved families intact and to facilitate successful outcomes from one generation to the next. This presentation will focus on key components of a 2Gen approach as it applies to identifying and supporting opportunities for entire families to achieve their own visions of success.

Marjorie Sims is Managing Director for Ascend at The Aspen Institute in Washington, DC. She has 20+ years of experience in advancing the status of women and families at local, state, national, and international levels. She served previously as Program Officer at the W.K. Kellogg Foundation with a specific focus on family economic security programs and managed a \$65 million grant portfolio. Sims previously held the positions of COO, Interim President, and VP of Programs and Operations at the Washington Area Women's Foundation, where she helped launch Stepping Stones, a \$5 million, multi-year regional initiative to increase the income and assets of women-headed families. In addition, Sims served as Executive Director of the California Women's Law Center and as a Policy Analyst with the International Center for Research on Women.

The HOMEBUILDERS® Model: An Overview and Lessons Learned

This session will provide an overview of the HOMEBUILDERS® Model of Intensive Family Preservation Services, which has been identified as an evidence-based program (EBP) and a well -supported program for FFPSA. Program standards and fidelity measures will be discussed, as well as the HOMEBUILDERS® "site development," implementation process, and quality assurance/enhancement strategies. Implementation lessons learned over the past 35 years will be described, and strategies to support strong program fidelity will be presented.

Shelley Leavitt, PhD, is Associate Director of the Institute for Family Development (IFD), the parent agency of the HOMEBUILDERS® program, where she directs IFD's Training and Dissemination Division and manages IFD's HOMEBUILDERS® program and other in-home family counseling programs in the Greater Seattle area. Prior to joining IFD, she designed and evaluated training and dissemination materials for children and families at Father Flanagan's Boys Home (Boys Town, NE). She is the author of Active Parenting and coauthor of Helping Kids Make Friends. She has provided training, technical assistance, and consultation on developing, implementing, managing, and evaluating HOMEBUILDERS® and other intensive family preservation programs throughout the United States and numerous countries around the world.
